#### SPRINKLER UPDATE

- Mike, Billy and Stephanie Smith met with David Smith [City of Bedford], 2-22-2022, regarding our sprinklers at Forest Ridge and Cummings
- The sprinkler repairman, said we just need 1 meter on the north side of the property
- David said this would cost the City \$1600-\$1800 for one new meter and a tap, and that the City could pay for this. David & his supervisor are meeting w/Billy next week to confirm repairs needed
- This will get us access to water on north side of Cummings going west
- Wendover and Cummings-Repairman will check out this meter for leaks as well

#### TREASURER - ERICH

- Erich provided a 2022-budget estimate
- He suggests rolling 4 expenses into one expense folder titled 'Neighborhood Maintenance' w/subfolders-erosion control, enhancements, sprinkler repair, trees
- 2022 Budget will be presented at the Annual HOA Meeting
- 2021 Budget shows us approximately \$7000 ahead \$5000 will go to fence escrow
- Suggestion made to have an additional person track the financials
  - Heather agreed to provide monthly oversight of funds
- Heather and Ken will meet at Chase Bank to update account signatures
- One homeowner has not paid dues. They have received multiple invoices over time

  and best course to follow
- Mike mentioned the Directory-will this go on website, how will it be accessed, etc.
